

# Engage Barrie Position Paper on Community Engagement July 2020

#### Context:

Effectively engaging with Barrie residents is fundamental to both helping the public and our elected representatives understand the nuanced challenges our community faces and to the development of sustainable solutions. This paper describes international best practices in public engagement, and Engage Barrie's expectations regarding public participation in decision-making processes on civic matters.

### **Key Principles:**

The <u>IAP2 Spectrum of Public Participation</u><sup>1</sup> is the international standard in public engagement, and offers five levels of participation that can define the public's role in any deliberative process:

#### Inform + Consult + Involve + Collaborate + Empower

This Spectrum also lays out the goal and the promise to the public for each.

The IAP2 Spectrum can be used in the design stages of a community engagement process to clarify the objectives of engagement and identify the appropriate tools and techniques for participation that has integrity. When the commitments of the determined level of engagement are kept, trust is built with participants. It also contributes to the transparency, accountability and credibility of the decision-making process.

Given these best practices, it is Engage Barrie's expectation that when it comes to civic matters:

- Public participation is expected, encouraged, facilitated, and adequately resourced.
- Public participation presented at the "Consult" level or above (surveys, public meetings, advisory committees) is intended to influence the decision.
- The process is designed to address barriers to public engagement and allow meaningful public participation.
- When a public participation process is presented at the "Consult" level or above, it is designed to communicate how public input affected the decision.

#### Conclusion:

Meaningful public engagement is at the heart of a well-functioning democracy. As Barrie strives to become a more healthy, resilient community where each resident can participate and thrive, every
