# Welcome to our first Annual Members Meeting!

After a couple years of life as a grassroots movement, Engage Barrie Organization was incorporated as a not-for-profit in June, 2021. The Founding Board consisted of five Directors: Randy Aylwin, Kenzie Churchward, Myrna Clark, Paige Power, and Alyssa Wright. These five worked hard to build a solid foundation from which Engage can confidently grow into the future, and we are grateful to them all.

At the time of publishing, we have 36 "Contributing Members" (34 voting, 2 non-voting), and 56 active members. Thank you for your faith in the Organization, and for all you have done in the past year to help support it – from joining a committee, writing an article, offering an idea or criticism, sharing a social media post, or encouraging people to vote (it really can be as simple as that). You've all been an essential part of this organization, and we deeply appreciate you all.

The behind-the-scenes work of incorporating as a not-for-profit was our primary focus through much of 2021 – and continues on as we develop policies and procedures to keep the organization running smoothly. Other things we focused on this year were developing our website, making new and strengthening existing connections with other community organizations, and continuing work on the campaigns and issues that brought us all together in the first place. Plus, of course, the provincial election, and preparing for the municipal election.

Rob Romanek joined the Board in February, to replace Randy after his resignation, and Victoria Scott answered the call in October, when Kenzie resigned to focus on her business. Thank you to both, for completing our Board for the remainder of the term as First Directors.

In the coming year, we're hoping to keep building on these foundations, expand the campaigns and issues we're working on, and develop more ways for our members to get engaged, both with us and local politics in general.

# What have we accomplished this year?

## **Becoming a non-profit**

This was, of course, the main focus of 2021, and continued (and continues) into 2022.

Beginning in the spring of 2021, the Founding Board put together Engage Barrie Organization's application for incorporation as an Ontario not-for-profit, which was granted in late June.

Building on the work of many of our original contributing members, the Board developed and solidified our mission, mandate, values and founding principles. We continue to develop policies and procedures to keep Engage operating according to those foundations, and true to our original grassroots.

Shortly after Engage was incorporated, the Ontario Not-for-Profit Corporations Act (ONCA) was proclaimed, so much work continues to be done behind the scenes, as we transition from the old legislation to comply with the new. We'll be holding a Special Members Meeting in the next year or so, to approve a few minor changes to our Articles of Incorporation, so we can finalize the transition.

## Website Relaunch

Engage launched its new digital home in September, at www.engagebarrie.org, and we continue to develop the site.

The website is an information portal and a gathering place. Members have access to private channels in our web forum for conversations on the issues that mean the most to them. Those who have something to say can contribute articles to our blog. And we're adding information and resources regularly.

In development for the site is an interactive vote tracker (thanks to contributing member James Kerekes), so you can see how council voted on the matters that mean the most to you. We're also putting together pages for each issue we've been paying attention to, plus "report cards" for the 2018-22 term council members.

If there is a feature you'd like to see, please get in touch, and we'll try to make it happen!

## **Projects & Issues**

## **Community Connection Guide**

As one of the many partners under the Just Recovery Simcoe umbrella, we helped create this printed and online guide to local issues for municipal leaders and community changemakers, leading up to the municipal election.

## **Municipal Election Toolkit**

Spearheaded by the Simcoe County Food Council, we were one of many consulting organizations who helped prepare this toolkit, to help people understand the role municipalities play in ensuring a sustainable, resilient local food system that is affordable and accessible for everyone.

## **Harm Reduction / Supervised Consumption Site**

Shortly before we were incorporated, City Council approved the SCS, and we have since been waiting for provincial approval. But there has still been work on this issue:

- Responding to Doug Downey's survey (and our concerns over it) about the site
- Endorsing/supporting Bill C-216 (amending the Controlled Drugs and Substances Act)
- Articles, blog posts, deputations and letters to the editor

Also shortly before incorporation, we assisted the complaint to the Integrity Commissioner regarding former BIA Chair Hamilton's racist and offensive language around drug users - when no Council member took action, even after the story hit national media, it was one private individual (with the community's support) who was able to make a difference!

## **Accountability Team**

Keeping track of Council meetings, recording votes, and giving our synopsis (and critique) of what's happening at City Hall throughout the year. This team is also developing an interactive vote tracker and other means to keep the public informed on the decisions made at the Council level on our behalf.

#### **Ranked Ballot Elections**

Supporting Bill 80, the Local Choice for Local Elections Act (which, unfortunately, was dropped when the provincial election was called).

## **Workplace Harassment**

- Supporting Bill 10 / Bill 5, the Harassment and Abuse by Local Leaders Act
- Follow-up and analysis when story broke about the civil case coming forward
- Articles, blog posts, deputations and letters to the editor

## Public Safety

Supporting campaign for police-free schools, encouraging feedback for the municipal budget.

#### **Decolonization**

Supporting campaign to work with local First Nations and find alternatives to Canada Day celebrations, after more graves of Indigenous children were discovered in the weeks before.

## **Elections Committee**

Probably our busiest group outside of the Accountability team, with the spring provincial election, and preparing for the municipal election (which occurred after our fiscal year-end)!

- Recruiting candidates, especially women and under-represented communities
- Providing information pages for candidates and voters
- Preparing for all-candidates meetings in the fall
- Collaborating with other organizations to create toolkits/guides, and share / promote events and information they created
